#### **About**

The Professional Higher Technical course in Quality, Environmental and Safety Management provides a study plan for the certification of students with level five academic qualifications. It is a higher education course of a professional technical nature that provides a detailed framework of studies in the fields of management systems, namely quality, environmental and safety management. These are strategic areas and essential requirements for the good governance of organizations in today's contexts, with numerous customer requirements for the quality of products and services and various legal requirements in terms of licensing and the environmental impact of activities and in terms of health and safety at work. The professional profile of this course is published in the Bulletin of Labor and Employment (BTE) No. 40 of October 29, 2012. Its fundamental areas of study are Code 347 - Company Environment and 862 - Safety and Hygiene at Work. Successful completion of the study plan allows graduates to work as Quality, Environment and Safety Technicians, Quality Technicians or Environmental Technicians. In addition, it also provides the possibility of pursuing studies at degree level, within the scope of specific competitions and with an equivalence plan, when enrolling on an ISLA Gaia degree.
